

**MINEOLA CITY COUNCIL MINUTES  
REGULAR MEETING - MINEOLA CITY HALL  
NOVEMBER 23, 2020, 5:30 P.M.**

**CALL TO ORDER**     Mayor White called the meeting to order at 5:30 p.m. and confirmed a quorum of the council was present.

**PRESENTATIONS AND PROCLAMATIONS**

1. Gene Keenon with Republic Services to present Mineola Nature Preserve a donation of \$5,000.

Mr. Keenon presented Mrs. Rushing a check for \$5,000 for the Nature Preserve to use as it needs.

2. Presentation of proclamation to the Mineola Rotary Club in celebration of their 80th anniversary in Mineola.

Mayor White read the proclamation, proclaiming November 23, 2020 as "Rotary Club of Mineola Day" and presented it to Mrs. Denise Hurst, current president of the Rotary Club.

10. Consider action of a board member appointment of Angela Thompson to the Mineola Parks and Open Spaces board for a two year term, replacing Mary Lookadoo who retired.
11. Consider action on an Interlocal agreement for Fire Protection and Emergency Service for FY 20-21 between the City of Mineola and Wood County and authorize the Mayor to execute the agreement.
12. Consider action on an Interlocal agreement for Emergency Management Plan for FY 230-21 between the City of Mineola and Wood County and authorize the Mayor to execute the agreement.
13. Consider action on an Interlocal agreement for Emergency Management Coordinator for FY 20-21 between the City of Mineola and Wood County and authorize the Mayor to execute the agreement.
14. Consider action on a request to auction surplus property.

Councilmember Sue Jones made the motion to approve consent agenda. The motion was seconded by Councilmember Greg Hollen and carried by a majority roll-call vote.

- 15. Discuss and consider action on an ordinance amending the city's Code of Ordinances, Chapter 40 Taxation by adding Section 40-4, Telecommunication Service Tax.**

Councilmember Mitchell Tuck made the motion to adopt Ordinance 20-11-23-15. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

- 16. Discuss and consider action on award of bid for the Stone Street Sewer Improvement project MN.164 to D and D Pipeline Consultants, LLC in the amount of \$235,371.00.**

Councilmember Polly Jones made the motion to award the bid to D and D Pipeline Consultants, LLC. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

- 17. Discuss and consider action on a budget amendment ordinance for the Coronavirus Emergency Supplemental Funding (CESF) Program.**

Councilmember Polly Jones made the motion to adopt Ordinance 20-11-23-17. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

- 18. Discuss and consider action on a purchase to Peacemaker Technologies LLC for software and equipment for Police vehicles in the amount of \$67,050.**

Councilmember Jayne Lankford made the motion to approve the purchase. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

- 19. Discuss and consider action on 2021 Meredith Requests.**

Mrs. Rushing presented the different projects and programs that the departments have submitted for consideration. Each department sent in projects they felt were very important. She will send a scoring sheet to each councilmember for them to rate each project from most important to least important. Those scores will be tabulated to determine the order the projects will be submitted to the Meredith for consideration. No action was taken on the item.

**20. Mayor Comments – regarding matters appearing on the agenda; recognition of community members, city employees, and upcoming events; inquiry of staff regarding specific factual information or existing policies.**




**ADJOURNMENT**
